Top 10 Highlights of the First Decade of Enhancing Our Library

In 1997, a \$1 million gift was made by **Orrin W. Macleod** for the purchase of audio books for Fairfax County Public Library.

In 1999, businesses that contributed to our Library included a partnership between **Washington Gas and Columbia Energy Group** that donated \$60,000 to establish an energy and environment collection in our Library.

In 2000, the **New Century Library Fund (NCLF)** was formed to address the Library's most critical needs, including books and materials, community programs, and the Virtual Library.



In 2001, the New Century Library Fund reached the \$100,000 mark and the **Friends Scholarship Fund** was added to the NCLF to address the impending shortage of qualified Library staff.

In 2002, the **Friends of the George Mason Regional Library** created a \$500,000 Children's Reading Fund endowment to sustain the very popular Summer Reading Program.

Through a generous grant from an anonymous foundation, the Library Foundation established a family literacy outreach program based on the national award-winning **Motheread®/Fatheread® program** through the Virginia Foundation for the Humanities targeting preschool children and their families in the neediest areas of Fairfax County.

> In 2003, tribute and memorial gifts were encouraged by the example of the **Shelley A. Marshall Foundation**. This special memorial, created in honor of one of the heroes lost in the terrorist attack on the Pentagon, provides funding for monthly • story times at the Patrick Henry Library.

ExxonMobil generously supported our Library in many ways, including the Community Summer Jobs Program, which funded internships that were used to begin outreach programs; awarding grants for the purchase of Children's Foreign Language collections; volunteer matching contributions; leadership on the Library Foundation's Board of Directors and event sponsorship.

In 2004, a record amount of over \$1,064,625 was raised by 1,396 Library supporters. Among these, **A.J. Dwoskin & Associates** made the first of 10 annual gifts to the New Century Library Fund to enhance the Library's collection of books and materials, educational opportunities, family programs and technology. This generous gift is estimated to exceed \$730,000 over the next decade.

> The Capital Book Festival: A Celebration of Notable Authors was held on May 8th in celebration of the Foundation's 10th Anniversary of enhancing our Library through private support. This grand event, led by Immediate

Past Chair, Alice M. Starr, featured the first-ever Capital Book Award; autographed book sales and special children's readings and activities. Over 40 notable authors volunteered to host thought-provoking presentations and workshops netting \$100,000 for the New Century Library Fund.


